PUBLIC COMMENTS: Jarrod McDaniel is licensed electrician by trade and owner of Liberty Electric here in town. In the year and a half, he has lived here, he has seen hazardous electrical work done by unlicensed people. He heard residence saying permits are no longer required and he believes people think license are not required. He said that he had called City Hall twice and asked what he needed to do to preform electrical work in Clarendon and was told he did not need a license. He contacted the State and was confirmed any person offering to do electrical work in Texas must be licensed. There is a \$2,000 to \$6,000 fine per occurrence for unlicensed people doing electrical work. Homeowners who are homesteaded can do their or electrical work to their home only. He believes the City needs to put something in the paper to correct this misunderstanding and inform citizen to make sure people they hire are licensed.
