MAYOR COMMENTS: Mayor Skelton informed Council that the handicap ramp committee has met twice and decided to put the ramp in front of the steak house at second and Kearney. The Mayor and Administrator met with the engineer and he has already submitted a design for the ramp and replacing the sidewalk, we are now waiting on a cost for the design. Once the cost is received, we will call another committee meeting.

He has not met with the Sheriff yet on the request for more information about tickets written in city limits from the previous Council meeting. He and the Administrator have been busy with the sanitation contract and the Chuckwagon Cook-off. He will contact the Sheriff and set up a meeting with himself, the Administrator, Alderman Fangman, and Judge Waldrop and have some answers at the next meeting.

The Mayor and Administrator went to the meeting with Representative Ken King at the Mulkey and Rep. King stated that Texas was facing a deficit of 20-25 billion dollars due to the loss in the oil industry. King said the Governor may raise the sales tax 1% to make up for the deficit.

COUNCIL COMMENTS: Alderman McIntosh passed out a flyer for devices that supply wi-fi wherever you are at that the Library can obtain and checkout to the public. They are donated by the Talker Foundation free for the first year. They are \$300 each and \$3,000 total if they choose to purchase them. The Library board will need to meet and decide on them. The Library board is also hosting a fundraising event to boost morale in the community called the "Scarecrow Contest". Individuals or businesses can build and display their scarecrow with the community choosing the winner by voting on FaceBook or at the library on October 31st.
